I. Call to Order and Roll Call (*4:29 YouTube*)

Executive Assistant Valerie Neumann confirmed that the meeting agenda was properly posted at least 48 hours prior to the meeting.

II. Approval of minutes from Dec. 22, 2021 *(6:22 YouTube)*

Commissioner Mehl motioned to approve the General Session and Executive Session Minutes from Dec. 22, 2021; Vice Chair Watchman seconded the motion. The motion was approved 5-0.

The Commission thanked the public for their involvement and commented on the variety of reactions to the final maps. Chair Neuberg stated that regarding the Congressional districts, the Commission respected communities of interest, and all regions were represented well. Regarding the Legislative districts, the Commission did their best to maximize as many communities of interest having representation as possible, and the minority communities were well represented.

Mark Flahan from Timmons/NDC advised that to date, six counties have responded with technical changes to the maps, which his team is processing. The county submission deadline was Dec. 30, 2021, with one county which asked for an extension to December 31, 2021. If a county does not respond with a technical request, the mapping team will do a final review of the maps for any issues.

Doug Johnson from Timmons/NDC advised that there were no additional updates at this time for the Constitutional Criteria data review.

Commissioner Lerner expressed several of her concerns regarding competitiveness, communities of interest and geographical boundaries constitutional criteria flaws within the final Congressional map. Lerner stated she had already presented her concerns with the Legislative map at the final deliberation meeting.
