Pursuant to Article IV, Part 2, § (12) of the Arizona Constitution and A.R.S. §38-431.02, notice is hereby given to the Commissioners of the Arizona Independent Redistricting Commission and the general public that the Arizona Independent Redistricting Commission will hold a meeting open to the public on April 2, 2004, at 8:30 a.m. at the Wyndham Buttes Resort, 2000 Westcourt Way, Tempe, Arizona in the Kachina Ballroom.

**NOTE: All matters on the agenda may be presented, discussed and/or are subject to possible decision by the Commission in person or electronically.**

The agenda is as follows:

**The Commission requests that speaker's be as concise as possible in their oral presentation to the Commission. Groups of speakers on the same issue should designate one or two representatives to address the Commission if possible. Written comments of any length may be provided to the Commission to supplement or instead of an oral presentation. Please provide the Commission with 10 copies of any documents submitted at the meeting.**

NOTE: The Commission may hold additional public comment periods during this public meeting on the call of the Chairman as necessary and appropriate to accommodate the public.

The Commission may vote to go into one or more executive sessions, which will not be open to the public, for any item listed on the agenda, for the purpose of discussion or consultation for legal advice with the Commission's attorneys pursuant to A.R.S. §38-431.03(A)(3) and/or for the purpose of discussion or consultation with the Commission's attorneys in order to consider its position and instruct its attorneys regarding the Commission's position in pending or contemplated litigation pursuant to A.R.S. §38-431.03(A)(4).
