Pursuant to Article IV, Part 2, § (12) of the Arizona Constitution and A.R.S. §38-431.02, amended notice is hereby given to the Commissioners of the Arizona Independent Redistricting Commission and the general public that the Arizona Independent Redistricting Commission will hold a meeting open to the public on May 20, 2002, at 6:00 p.m. at the Wyndham Buttes Resort, 2000 Westcourt Way, Tempe, Arizona. If it is necessary to recess that meeting, the Commission will hold a resumed public meeting on May 21, 2002 at 8:00 a.m. If it is necessary to recess the May 21, 2002, meeting, the Commission will hold a resumed public meeting on May 23, 2002 at 8:00 a.m. All regular and resumed meetings will be held at the same location.

The Commission may vote to go into executive session, which will not be open to the public, for any item listed on the agenda, for the purpose of discussing personnel matters (A.R.S. §38-431.03(A)(1)), consulting with Commission attorneys, regarding pending or contemplated litigation (A.R.S. §38-431.03(A)(4)), or obtaining legal advice (A.R.S. §38-431.03(A)(3)).

\* If the meeting resumes on this date, it will be at the time set by the chairman when the prior day's meeting is recessed. The time set will be no earlier than 9:00 a.m. and may be later.

The agenda for each of these meetings is as follows:

- II. Public Comment.

This is the time for consideration and discussion of comments and complaints from the public. Those wishing to address the Commission shall request permission in advance by filling out a speaker slip. Action taken as a result of public comment will be limited to directing staff to study the matter or rescheduling the matter for further consideration and decision at a later date unless it is the subject of an item already on the agenda.

NOTE: The Commission may hold additional public comment periods throughout these regular and resumed public meetings on the call of the Chairman as necessary and appropriate to accommodate the public.

- III. Presentation concerning the May 20, 2002, Department of Justice objection to the Arizona Legislative Redistricting Plan, including possible presentation by Bruce Adelson, U.S. Department of Justice.
- IV. Possible update and/or decision concerning the voter registration data issue.
- V. Possible presentation(s) by NDC and legal counsel, discussion(s) and possible decision(s) concerning alternatives and changes to the adopted Legislative Redistricting Plan to address the May 20, 2002, objection to the Arizona Legislative Redistricting Plan from the United States Attorney General under Section 5 of the Voting Rights Act.
- VI. The Commission may vote at any time to go into an Executive session that is not open to the public for the purpose of discussion or consultation for legal advice with the Commission's attorneys pursuant to A.R.S. §38-431.03(A)(3) and for the purpose of discussion or consultation with the Commission's attorneys in order to consider its position and instruct its attorneys regarding the Commission's position in pending or contemplated litigation pursuant to A.R.S. §38-431.03(A)(4).
- VII. Discussion of possible future Commission Meeting(s).
- VIII. Possible Executive Director's report.
- IX. Recess or Adjournment.

**NOTICE is hereby given that the Commission meeting may be recessed in public session on May 20, 21 or 22, 2002, to be resumed on the mornings of May 21, 22, or 23, 2002, at the times and locations set forth herein. Before recessing, the Commission Chairman will state the time at which the meeting will resume and will state which portion of the foregoing agenda will be the agenda when the meeting resumes the following morning.**
