NDC was asked by the Chairman to begin with a brief presentation with respect to the Congressional map, then turn to general terms on broad overview issues which include areas where there are any alternatives. Problem areas will be addressed. Any areas Commissioners wish to address for further review or study based on the second round of citizen input will then be raised.

Motion was made, seconded and carried pursuant to A.R.S. 38-431.01(A)(3) to recess Public Session and go into Executive Session.

Whereupon the Commission was in Executive Session from 5:32 p.m. until 6:40 p.m. at which time Public Session was reconvened.

Motion was made, seconded and carried to retain as much of the AUR in District B as possible and yet still keep B a competitive district. Commissioner Minkoff suggested she felt the best way to do so may be adjusting the line north.

Motion was made and failed for lack of a second to give map CC no further consideration.

Motion was made, seconded and tabled while the test (which was running during discussion of the motion finishes) that map FF, which places Verde Valley into K, more of the western river communities into C, and minimizes the influence of Maricopa County into G, the request is to take FF or some appropriate variation and dovetail D as it exists and some appropriate configuration of New Competitive B to see how that impacts all of the other goals as stated in Proposition 106. Motion to table the motion until the test completed.

Motion was made, seconded and carried to incorporated Biltmore 2 and eliminate Biltmore 1.

Motion was made and seconded regarding the 3AA test and the Tucson Salt River change that those amendments be included to the adopted draft. Discussion was had on the motion. Motion was made, seconded and carried the Salt River Tribes, include what Native American Tribes requested to be included with the Metropolitan District and what had been excluded from the rural District C.

Motion was made, seconded and carried to eliminate FF from the table.

Motion was made, seconded and fails three to two to take FF, take D as exists with FF, overlay new Competitive B working on whatever is the instruction for working on the best consideration D, what is the best culmination of D and G, specifically of the majority-minority voting rights issues.

Motion was made and died for lack of a second CC be taken off the table from consideration.

Motion was made, seconded and carried to remove test Downtown CD due to the negative effects of D, referring to Section Five issues.

Motion was made, seconded and carried to include the Sahuarita change in the map.
