VI. Executive Director's Report. (7:15YouTube)

Executive Director Brian Schmitt provided an update on staffing, which consists of himself ant Executive Assistant Valerie Neumann. Deputy Director Lori Van Haren is assisting with Public Records Requests as needed, and finishing up any special assignments.

The IRC Conference Room is being released back to the State, as it is needed for another agency. This will provide some cost savings to the IRC, as the space is no longer needed.

A summary of past fiscal year expenditures was given by Schmitt:

\$614K Personnel services, and employee related expenses

\$4.3 Million went towards professional and outside services (legal & mapping)

\$21K Travel related expenses

\$847K Operating expenses (meeting rooms and related items)

\$23K Noncapital expenses (laptops)

The sub-total of expenses is approximately \$5.8 million, leaving an allotment of \$2 million remaining.

Schmitt is currently working with the Arizona Department of Administration and Timmons Group on a plan to integrate the IRC website which will be kept updated by ADOA, and available for the use of the next Commission.

Schmitt will be working on a plan to archive and sunsetting the IRC once the legal challenges are closed out.

The Commission addressed agenda item V next.

Commissioner York motioned to move into Executive Session, Commissioner Lerner seconded the motion. The motion was unanimously approved 5-0.

Upon returning from Executive Session, the Commission directed the Legal team to research and prepare a response for the review of the Commission regarding to Pinal County Attorney's Office regarding the Democratic National Conventions allegations.

The Commission is expecting feedback on the Conway vs. Independent Redistricting Commission within the next 60 days.

The Commission received a legal update on the Moore v. Harper case before the U.S. Supreme Court. This case is regarding who ultimately has authority over elections. The Commission asked the Legal team to investigate and do additional research on this issue and provide a legal overview to the Commission at the next meeting.
