Pursuant to Article IV, Part 2, § (12) of the Arizona Constitution and A.R.S. §38-431.02, notice is hereby given to the Commissioners of the Arizona Independent Redistricting Commission and the general public that the Arizona Independent Redistricting Commission will hold a regular meeting open to the public on August 2, 3 and 4, 2001. This meeting will be held beginning at 8:30 a.m. on August 2nd, 8:30 a.m. on August 3rd and 10:00 a.m. on August 4th at the Double Tree Guest Suites, Salons I and II, 320 N. 44th Street, Phoenix, Arizona.

The Commission may vote to go into executive session, which will not be open to the public, for any item listed on the agenda, for the purpose of discussing personnel matters (A.R.S. §38-431.03(A)(1)), consulting with Commission attorneys, regarding pending or contemplated litigation (A.R.S. §38-431.03(A)(4)), or obtaining legal advice (A.R.S. §38-431.03(A)(3)).

The agenda for the meeting is as follows:

- V. Presentation of revisions, discussion, and possible decision with respect to the schedule for the second round of public meetings.
- VI. Discussion and possible direction or decision with respect to the process for timely payment for professional services and to critical vendors.
- VII. Executive session(s) for discussion or consultation for legal advice with the Commission's attorneys pursuant to A.R.S. §38-431.03(A)(3).
- VIII. Possible presentation, discussion and possible decision with respect to the adoption of any additional AURs (Arizona Units of Representation).
- IX. Presentation by NDC, discussion and possible decision(s) concerning instructions to NDC on modifications of the grids for development of draft congressional and legislative maps.
- X. Public Comment. (Same guidelines as stated in agenda item II).
- X. Future Commission Meeting(s).
- XI. Recess or Adjournment.
