NOTICE OF PUBLIC MEETING AND EXECUTIVE SESSION OF THE ARIZONA INDEPENDENT REDISTRICTING COMMISSION

Pursuant to Article IV, Part 2, § (12) of the Arizona Constitution and A.R.S. §38-431.02, notice is hereby given to the Commissioners of the Arizona Independent Redistricting Commission and the general public that the Arizona Independent Redistricting Commission will hold a regular meeting open to the public on September 24, 2001. This meeting will be held beginning at 10:00 a.m. at the Double Tree Guest Suites, Salons I and II, 320 N. 44th Street (44th Street and Van Buren), Phoenix, Arizona.

The Commission may vote to go into executive session, which will not be open to the public, for any item listed on the agenda, for the purpose of discussing personnel matters (A.R.S. §38-431.03(A)(1)), consulting with Commission attorneys, regarding pending or contemplated litigation (A.R.S. §38-431.03(A)(4)), or obtaining legal advice (A.R.S. §38-431.03(A)(3)).

The agenda for the meeting is as follows:

- I. Call to Order.
- II. Public Comment.

This is the time for consideration and discussion of comments and complaints from the public. Those wishing to address the Commission shall request permission in advance by filling out a speaker slip. Action taken as a result of

public comment will be limited to directing staff to study the matter or rescheduling the matter for further consideration and decision at a later date unless it is the subject of an item already on the agenda.

- III. At the conclusion of Public Comment, but not earlier than 11:00, the Commission may vote to go into an Executive session that is not open to the public for the purpose of discussion or consultation for legal advice with the Commission's attorneys pursuant to A.R.S. §38-431.03(A)(3) and for the purpose of discussion or consultation with the Commission's attorneys in order to consider its position and instruct its attorneys regarding the Commission's position in pending or contemplated litigation pursuant to A.R.S. §38-431.03(A)(4).
- IV. At the conclusion of the Executive Session but not earlier than 2:00: possible presentation by NDC, discussion(s) and decisions(s) concerning the results of tests on possible or proposed alternatives to the draft congressional and legislative districts and further instructions to NDC on alternatives for continued and/or future consideration by the Commission.
- V. Discussion and possible decision concerning the Commission's timeline and the schedule for future Commission meeting(s).
- VI. Public Comment. (Same guidelines as stated in agenda item II).
- VII. Recess or Adjournment.
