Congressional District Testimony

Hello, my name is Llama Habern and I drove all the way from the Verde Valley to make it clear that those of us in the Verde Valley feel a much greater affinity to Flagstaff. Prescott has its own needs and issues and those are different from the Verde Valley's. Coming to the other side of Mingus Mountain differs from going up 89A to Flagstaff, which is where we go to find medical care and specialty services. Flagstaff is our city. We would much rather be included with Flagstaff in a Legislative District like LDF 050, rather than have Prescott speak for us.

Additionally, I recommend that the IRC adopt the map CDF 010, proposed by the Navajo Nation's Human Rights Commission. We should listen to and respect Native Americans' desire for their district. This map offers a district where the congressional race would be competitive – meaning more participation in elections, a larger variety of candidates, and every single vote mattering. CDF 010 allows Native American voices – and all of our voices – to be heard.

The current IRC CD 2 map is outside the IRC's definition of competitive. The district proposed by the Navajo Nation's Human Rights Commission is competitive, with less than a 1% advantage to either party, and it is more compact and contiguous than the IRC's CD 2 map. This fulfills all the requirements of Prop 106, which was passed by Arizona voters.

It is possible to create a district that fulfills the letter AND the spirit of Prop

Adopt map CDF 010 and show voters that the IRC will fulfill the requirements of Prop 106.

- My name is Kristin Baumgartner. I've been a resident of Prescott for the past 7 years. I'm here today to urge you to make Communities of Interest versus Competitiveness of the districts a priority in the final maps.
- Yavapai county should continue to be kept together as currently proposed in the LD5 district map. Thank you for recognizing that.
- Here are some community of interest reasons to reinforce your decision.
 - Yavapai county residents want to preserve our rural lifestyle and culture of strong spiritual and family values and conservation of the land, water and wildlife.
 - We need to be aligned with the county where we pay taxes and have a voice in how those funds are used.
 - There are a number of shared county and community services medical facilities, law enforcement, fire districts, library network, Yavapai college, etc.
 - Prescott has a Costco, Trader Joe's and other services that attract shoppers from across the county.
 - o The Big Chino Basin and the Verde Valley are part of the same watershed. Flagstaff is NOT part of that watershed. Good Morning, Commissioners. My name is Rita Day, I've lived in AZ for over 10 yrs, with the last 5 years being in Prescott.

I feel that the mapping team has failed miserably in providing Northern AZ with even One competitive district. The vote spread of the N. Arizona district maps ranges from 28.5% for LD5 to 48.5% for LD30. In contrast, Map LDF50 submitted by the public has less than 1% vote spread. This would be the MOST COMPETITIVE LD in the state. Furthermore, it keeps Flagstaff & Sedona whole and includes the Verde Valley, which the resident overwhelmingly prefer based on testimony at IRC hearings.

Also, The Map CDF10, submitted by the Navajo Nation has a vote spread of 1%. So it also is far superior to the map drawn by the mapping team. Therefore, this map should be given highest priority.

Prop. 106, which created the IRC, lists 6 criteria for creating FAIR maps. However, competitiveness is the ONLY criteria mentioned in the 1st sentence of Prop.106, showing the importance of competitiveness. Competition within districts encourages moderation, while in Safe districts, representatives have NO motivation to be accountable to large portions of their constituents. Furthermore Extremism and Corruption can spread more easily in SAFE districts. We have definitely seen a rise in extremism in the last few election cycles. So this is a major concern for our State and Country.

So, please substitute the competitive maps, LDF50 & CDF10 for maps drawn by the mapping team, as these maps are far superior.

Finally, I want to thank those commissioners who do this difficult job in a Nonpartisan way! Thank you very much.

My name is Harry Oberg, and I am a Yavapai County Supervisor.

I would like to respond to both of your current draft maps.

I request that you give serious consideration to CD0068 in developing the IRC's final map. Map 68 more properly aligns Yavapai County's communities of interest than your CD map. Due to concern with our scarce water resources in north central and western Arizona, this community of interest is more closely aligned with the western counties of Mojave, La Paz, Gila and portions of Coconino County than with the eastern counties depicted on your map. The district boundaries shown in Map CD0068, align the Eastern counties with their common communities of interest into their own CD. Combining these eastern counties naturally establishes a minority-majority district and would provide congressional representation specifically attuned to unique Native American interests.


In reference to your current draft LD map, we fully support this map and believe that establishing Yavapai County as its own LD is appropriate due to our census numbers. Also, this map supports our long-standing communities of interest across the county including our Western rural heritage, culture, and lifestyle, and our collective concern in Yavapai County for saving our primary community of interest, the Verde River.

To have the greatest hope of saving the longest surviving living river in Arizona, our county must remain whole as its own Legislative District. The only proposed changes to your LD map would be to include the entire Towns of Sedona and Wickenburg in LD-5 so as not to split these communities between two Legislative Districts.

ANOTHER EXAMPLE IS WATER. WATER MANAGEMENT AND CONSERVATION WILL ALWAYS BE AN ISSUE HERE IN ARIZONA, ON A LOCAL, STATE AND FEDERAL LEVEL. THE LITTLE CHINO AQUIFER SUPPLIES THE HEADWATERS OF THE VERDE RIVER AND IS IN THE PRESCOTT ACTIVE MANAGEMENT AREA, ALL OF WHICH ARE IN YAVAPAI COUNTY. THE MAPS WILL SEPARATE THE HEADWATERS AND THE AQUIFER FROM THE RIVER, CREATING A FUTURE QUAGMIRE OF JURISDICTIONS CONCERNING ADWR, SRP, WATER RIGHTS AND WATER LAW AND CONSERVATION AND MANAGEMENT EFFORTS TO NAME A FEW.

PRESCOTT IS THE BIGGEST ECONOMIC DRIVER FOR ALL OF YAVAPAI COUNTY. WE DON'T COMPETE, BUT WE ENHANCE THE VERDE VALLEY THRU MUTUALLY BENEFICIAL ECONOMIC GROWTH AND DEVELOPMENT AND EDUCATION. AN EXAMPLE IS PRESCOTT'S YAVAPAI COLLEGE AND THE INNOVATIVE SOUTHWEST WINE CENTER IN CLARKDALE WHICH HAS BEEN IMPORTANT TO THE DEVELOPMENT OF THE WINE INDUSTRY IN THE VERDE VALLEY.

I'm in support of the 10.0 draft LD map. It is just what was intended by the 6 redistricting criteria mandated which we are required to adhere to in our AZ Constitution. Yavapai county is in line with like sized communities of interest. Please don't change that.

I realize that our Arizona Constitution mandates that redistricting begin with a grid map, ensuring that each Independent Redistricting Commission starts from scratch.

But these grid maps really take into account only two of the six criteria the commissioners are required to consider:

Those two are:

- Equal population; and
- Compactness and contiguousness
- But, in drafting the new district maps, commissioners must modify the grid maps to account for four other criteria:
- Compliance with the U.S. Constitution and the Voting Rights Act;
- Respect for communities of interest; ***
- Incorporation of visible geographic features, including city, town and county boundaries, as well as undivided census tracts; and (Which allows Flagstaff to be spun off)
- Creation of competitive districts where there is no significant detriment to other goals.
- Once those modifications have been done, the resulting draft may bear little resemblence to the grid map. The 10.0 draft LD map is just what we need and is right for our community.

I'm Geoffrey Parker, a concerned citizen of Yavapai County and a veteran of 27 years of service.

First, I thank the commissioners for their dedication to community service, their diligence and contribution of time and talent to serve us all.

Their outcome with maps, Version 10, reflects very well the criteria they were charged to apply here.

The commissioners have correctly drawn Yavapai County as its own legislative district.

When it comes to communities of interest, it should come as no surprise that political boundaries of a county in a rural area should come to be community of interest. Within these borders we vote for county representatives, we live under shared governance by consent of the governed, we share in the collection of taxation and the expenditure of revenues to meet needs across the county. Such shared governance includes:

- Water resources
- Education
- Law enforcement
- Communities services
- Roads and transportation infrastructure
- · And integration of policies between Yavapai County cities.
- And much more

No, this is not circular reasoning . . . it is the design and intent of such entities framed by those who laid out our boundaries long ago. We proudly identify, as we should, as Americans, citizens of Arizona, and citizens of our county. Those who, in 1891, drew this county's boundaries would surely be pleased with the community Yavapai County has become today.

As a result, Prescott, Prescott Valley, Chino Valley, Dewey-Humboldt, Cottonwood, Camp Verde, Rim Rock, Jerome, and Sedona are communities of interest constituting the community of interest we call Yavapai County. Any outcome other than shared representation would be unnatural as recognized under criteria that govern the IRC, especially given our population.

Arguments presented for other district boundaries based on "being competitive" in any partisan sense have no overiding standing under our constitution.

To divide the proposed new LD5 is to divide our county and divide this community of interest. To rebalance population criteria, it would have knock-on effects across many LDs and become an unnecessary and unjustified set back to the months of process that arrived at the excellent version 10.

So in closing, keeping Yavapai County as its own LD and retaining the entire Town of Sedona in LD-5 is fair and consistent with the constitutional principles that established the Independent Redistricting Commission.

Hello, and Thank You, Chairwoman Neuberg and commissioners for the opportunity to speak with you today.

My name is Mark Smith and I have lived in Arizona since the late 1950s. My wife and I are new 2-year residents of Yavapai County living north of Prescott in the Williamson Valley area, Zip Code 86305. I grew up in the west Phoenix area of Maryvale from the late 1950s to the late 1970s. We lived in Glendale from the late 1970s and moved to Avondale in the mid-1990s.

This brief personal history is to demonstrate that I am invested in the state of Arizona and the communities that I reside. When I became of legal age to vote in the mid-1970s, I began to see how districts where I lived were not represented by my beliefs and values that aligned with the local communities. A true example was the redistricting that took place more than 10 years ago that aligned far NE Avondale with the southern district area of Tucson. Avondale should not have been part of southern district of Tucson. This is my concern with the proposed redistricting maps now presented.

I believe all Yavapai County, the cities, the towns, rural communities and outlying areas should remain continuous with Yavapai County and not be fractioned off to other districts. We pay taxes in Yavapai County and support businesses within the county. Separating areas of Yavapai County reduces our ability to tell officials how to spend our tax dollars. Coconino County BOS doe does not represent Yavapai County. Black Canyon City should remain whole as a town of Yavapai County and not split into other counties. Redistricting Statement to IRC

Nov 20, 2021

Thank you, Madame Chair and Commissioners, for allowing our public input today.

I am Jeanna Tendall, a resident of Prescott.

I support the IRC's LD draft map with the addition to LD 5 of the portions of Sedona and Wickenburg that lie outside Yavapai County so as not to split these towns into 2 legislative districts.

I would also like to suggest a change to the IRC's CD draft map to allow for better alignment of communities of interest. On the draft map Yavapai County is grouped into the same CD as Navajo, Apache, and parts of Graham and Greenlee counties. However, there is a major community of interest misalignment in this arrangement—that being, water availability in the rural areas, which the IRC should take into consideration when drawing the new CD map. Yavapai County does not have the same abundance of water as in the tribal areas. Our water resources are scarce and require very diligent and continuous management. In contrast, one Tribe has agreed to make a significant water sale to Maricopa County this year to offset their CAP reduction.

To improve the CD map alignment, Yavapai County should be grouped in the same CD as other rural counties with similar water scarcity, those being: Mohave, LaPaz, Gila, and Coconino as shown in map Ref # CD0068. These counties require congressional and legislative representation that understands and advocates for the rural areas with scarce water resources. Combining Yavapai with the tribal counties will dilute this advocacy possibly resulting in what CA is experiencing where low water allocation to rural counties has led to fallow farms, rural bankruptcies, and rampant poverty, not to mention the significant loss of food production in the state. We don't want to go the way of CA.


My name is Marlene Macek and I live in the Village of Oak Creek, one of the unincorporated Verde Valley communities.



Talking points - Christy Magers, Yavapai County

Thank you for the opportunity to speak this morning regarding the redrawing of legislative districts that share the same community interests. I commend the Commissioners for the current 10.0 draft of the LD map.

I understand that there are existing groups such as the Princeton Gerrymandering Project who indicate that they are committed to "eliminate partisan gerrymandering at a state-by-state level." However, what an outside group decides is appropriate for the state of Arizona is of no consequence if it does not align with our state's constitutional provisions regarding redistricting.

Those constitutional redistricting provisions are as follows:

- 1. Compliance with the US Constitution and United Statesvoting rights act
- 2. Equality of population in each district
- 3. Compactness
- 4. Communities of Interest. These next two criteria are provisional.
- 5. To the extent practicable, use visible geographic features and borders.
- 6. To the extent practicable, <u>competitive districts</u> should be favored where to do so would create <u>no significant detriment to the other goals</u>.

I contend that the first four goals must be adhered to before considering the last two goals. Yavapai County and Coconino County are not communities of interest nor are the areas to be considered contiguous because of the distance and difficulty of access between the two areas.

Good morning, My name is Mike Schroeder from Sedona, AZ addressing this this hard working commission hopefully for the last time.

I have spoken to you about our tax responsibilities going to Prescott, the Sedona ties of the Verde Valley economic development plans and the interaction of county services that are unique to all our rural communities and to Prescott. Our travel times from the central Verde to downtown Prescott and Flagstaff are 10 minutes different.

I will not rehash what you have already heard.

This has been an exasperating experience for all of us over the past many months. But what is frustrating is that this commission did its job as outlined in points A thru F under paragraph 14 of the Arizona Constitution outling the requirements for the redistricting process. You came up with a map, version 10.0 that was in compliance with A thru F.

Now we have the Sedona City Council, none of which received more than 22% of the vote of the population of Sedona coming and stating that the Sedona City Council "unanimously" supports a district map that was created by Coconino County. As individuals they have every right to any opinion they want, whether aligned with the constitution guidelines or not. But they Do Not speak for 10,000 residents.

In addition, it would seem that the Coconino County Supervisors have enough on their plate managing a county bigger than many states.

But they are trying to extend their reach down into the Verde Valley where they have no jurisdiction.

- A. Districts shall comply with the United States Constitution and the United States voting rights act;

Good morning Commissioners, Thank you for giving the public the opportunity to speak to you on this timely and important issue of redistricting.

My name is Marion Pack, and I have been a resident of Prescott since 2002.

My remarks are mainly addressing the issue of communities of interest.

When I first moved here I thought it was rather funny that we in Prescott called Sedona "the other side of the mountain." It truly is the other side of Mingus Mountain, a geographic feature which slices the Verde Valley on the eastern edge of the county.

Sedona is different from Prescott in many ways. Sedona's economy depends almost exclusively on the thousands of people that annually visit Sedona. The entire Verde Valley with towns like Cottonwood, and Clarksdale benefits from the spillover of Sedona's massive tourism.

Prescott's economy is entirely different. Though we have a share of tourists, it is only a segment of our diversified economic base. We have a growing manufacturing and technology base. Prescott has just enlarged its airport to accommodate our expanding economic base and to encourage more business development to the area. Our growth is exactly what Sedona doesn't want!

Yavapai County is only one four other counties that is not split on the draft maps. Yavapai County is a huge county unlike the other small counties of Santa Cruz, Graham, Gila, and Pinal.

I ask that the map be redrawn to follow the current LD6 configuration. Please honor the weight of my community of interest testimony when making your decision.

I am a Yavapai County resident. I want to thank you for the current Legislation District map 10.0, as it keeps Yavapai County, Sedona, and Verde Valley together. These three geographic areas belong together in all ways that mater. It saddens me that so many people would argue to put Sedona and the Verde Valley with Flagstaff; especially when Sedona and Verde Valley have more in common with Yavapai County. The only reason to put a minority of rural citizens who are closer in median age to the mid-50's, with the big city community of Flagstaff, who's median age is closer to the mid-20's would be gerrymandering.

Beyond community make-up, Sedona and Verde Valley share similar interests and resources with Yavapai County. The dedication to hiking trails and outdoor activities, the joy of seeing and preserving wild life, merging library resources, the hosting of Yavapai College satellite campus', the way Sedona and Verde Valley citizens shop more in Yavapai County than Flagstaff; and Yavapai County citizens visit Sedona and Verde Valley community events as much as they attend Yavapai County community events.
